The report describes bundled payment program management solutions available in the market today and ranks them based on the maturity of the offering, product capabilities, and market execution. Out of 18 vendors reviewed, Clarify Health was ranked #1 overall.

- **Episode Definition** – Permits participants to specify the clinical elements of an episode including providers, treatments, medications, organizations, etc.
- **Quality Reporting** – Provides reports or dashboards with all contracted quality metrics for the episode.
- **Cost Reporting** – Provides reports or dashboards with FFS-based costs contained in the bundle definition for all participants.
- **Contract Management and Reconciliation** – Supports the allocation and distribution of payment share to participants.
- **Patient Engagement** – Functionality in an app or portal that allows the patient to interact with the care team and organizations involved in the episode.
- **Care Navigation Workflow** – Supports the design and specification of the workflow and handoffs across the network executing the episode.
- **Clinical Pathway Support** – Supports the design and specification of the clinical care plan that executes the episode.

Success in bundled payment programs as identified by Chilmark Research lies in providers' ability to execute on all 8 of the capabilities reviewed. A key finding of the report indicated that many vendors offer point solutions which offer limited value for the overall management of bundled payment programs. Clarify Health was identified as offering the most comprehensive solution for end-to-end program management.

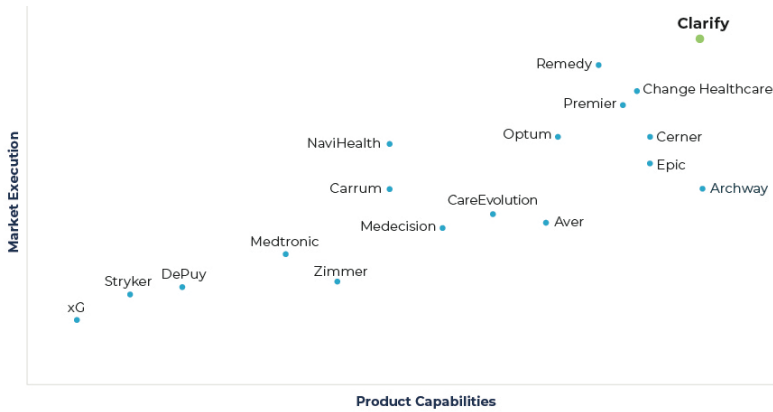
